# Preparing Like Squirrels for What's to Come

As I sit by the water this early fall weekend admiring the changing leaves with the explosive oranges, reds and yellows on the trees, it brings to reality that summer is ending and fall brings a certain amount of chores. While this is beautiful, it reminds me that I have to start thinking about fall and winter prep for our log cabin. So between the pumpkin spice coffee and apple cider donuts there are jobs that should be done as we prepare the cabin for the months ahead. Watching the squirrels gathering food like they never have enough is somewhat disheartening; if you look at the Farmer's Almanac, squirrels gathering nuts early forecasts snow and a colder winter.

So back to winter prep: How's your fireplace? When was it last used, but more importantly, when was it last cleaned or inspected? The NFPA (National Fire Protection Agency) says chimneys, fireplaces, and vents shall be inspected at least once a year for soundness, freedom from deposits, and correct clearances. If you are going to use your fireplace, it's recommended to get it inspected and cleaned. If you have an oil furnace, is your tank full and have you had the heating unit serviced? Same with a propane furnace; make sure your tank is full. If you close your cabin down for the season, has the water been drained from your pipes, and have you put antifreeze in your sink, tub and basin drains? Make sure your lawn furniture is secured and covered, and put your patio umbrella away. If you have a floating dock or swim platform, have you secured it or removed it from the lake yet. Don't forget to remove your ladder if you have one on your dock.

If your boat is on a freeway bring it back to your property, same if it's on a Club rack. The Club isn't responsible if it gets damaged over the winter. So as fall continues, be a good steward of your property. There is good evidence that mulched leaves contribute to the health of your lawn and plant beds by returning nutrients to the soil. Unmulched leaves left to linger are easily swept away by the wind, eventually ending up on a neighbor's property or the roadway where they become quite dangerous when wet. For everyone's sake, keep your yard tidy and after the holidays are over take down your decorations. No one wants to see ghouls and goblins at Thanksgiving or Christmas. 2020 has brought new challenges and many new neighbors to our community. Let's continue to keep our unique community safe and welcoming.

# Boat Removal Notice from Docks and Racks

#### Boats must be removed from all docks and from all racks on the western side of Highland Lakes by Thursday evening, October 15, 2020.

Please take NOTICE that all boats, canoes, kayaks, etc. on all Club docks must be removed by Thursday, October 15, 2020, in order to provide time for the Club's staff to relocate the docks for winter storage. This NOTICE also requires the removal of all boats, canoes, kayaks, etc. stored on the wooden boat racks and on the kayak racks *on the western side* of Highland Lakes by Thursday, October 15, 2020.

In alternating years, once the racks are clear the wooden boat racks on the western side of Highland Lakes are inspected and repairs are made if necessary in the fall and in the early spring. In addition to maintenance and repair, the purpose of this program is to require that all boats, canoes, kayaks, etc. return home in alternate years, ensuring that for the most part the spaces on these racks are actively used by members and not occupied by boats, etc. as simply storage locations.

Part F. of Club Rule No. 25 provides as follows: F. TRANSPORT TO RESIDENCE, REMOVAL TO STORAGE, PENALTIES FOR VIOLATIONS: Boats, kayaks, windsurfers, etc. of members stored in violation of these Rules which can be identified will be returned to the member's residence. Boats which cannot be identified shall be removed to storage. All boat removals will be subject to a special assessment of \$100.00. A daily storage charge of \$5.00, calculated from the date the boat was removed to storage up to December 15 will be imposed, when a special winter storage fee of \$250.00 will then be imposed. After June 15, a disposal fee of \$250.00 will be imposed. Boats may not be retrieved between December 15 and April 15. The Club may, in its sole discretion, elect to acquire title to any boat that has been determined to be abandoned, in compliance with the "Abandoned Vessels Disposition Law," N.J.S.A. 12:7C-7 et seq.

(Adopted May 16, 2014 / Amended February 15, 2019) The following boat and kayak rack locations on the western side of Highland Lakes are affected by this notice:

Lake 5 - Pocasset Road - Beach 7 area

Lake 1 - Lakeside Drive - Beach 1 area

Main Lake - western shore areas as follows:

Club Park

Comet Row

**Eckhart Sailing Center** 

Crayfish Run Freeway at Winetka Road

Sunrise Path Freeway at Wiscasset Road

Freeway at Oneota Road

<u>Running Brook</u> Freeway at stream crossing south of Oneota Road

<u>Catfish Path</u> Freeway south of Ocala Road Freeway north of Monadnock Road

Freeway at Lakeside Drive East near Main Lake dam spillway

Avoid costly removal and storage assessments – remove your boats from all docks and boat racks as described above by October 15.



HOW MUCH DO I NEED TO PAY? If you own one home, your TOTAL CHARGES for calendar year 2021 are \$1,335.00. Pay \$1,310.00 by October 31 to get the \$25.00 Early Payment Discount. If you own ONE lot, your **TOTAL CHARGES** for calendar year 2021 are \$836.00. Pay \$821.00 by October 31 to get the \$15.00 Early Payment Discount. If you are unsure of what to pay, call the

WHEN ARE THE 2021 CHARGES DUE? By October 31, 2020, for the Early Payment Discount or by February 28, 2021, UNLESS your partial payments qualify (cabin owners only) for the LATE PAYMENT CHARGE GRACE PERIOD (see below).

CABIN (HOME) DUES: \$1,295.00 Members will be assessed Cabin Dues for each cabin owned. For the Early Payment Discount of \$25.00, see the <u>Early Payment Discount Program</u> section. The 2021 Cabin Dues will be invoiced to the owners of record on January 1, 2021, payable not later than February 28, 2021. For partial payments, see the Late Payment Grace Charge Period section for further information

<u>LOT DUES: (Badges not included): \$796.00</u> All owners of lots, including Cabin Owners owning lots, will be assessed Lot Dues on each lot owned. For the Early Payment Discount of \$15.00, see the <u>Early Payment Discount Program</u> section. Full membership privileges (badges, parking and boating permits) may be purchased with an additional payment of \$499.00. The 2021 Lot Dues will be invoiced to the owners of record on January 1, 2021, payable not later than February 28,

SPECIAL DAM REHABILITATION ASSESSMENT: \$40.00 - Members will be assessed \$40.00 for each lot and cabin owned to continue the inspections and rehabilitation of the Club's dams, and to provide for payment of the annual loan amounts due the State of New Jersev. The 2021 habilitation Assessment will be invoiced to owners of record on January 1, 2021, payable not later than February 28, 2021. For partial payments by cabin owners, see the Late Payment Grace Charge Period section for further information.

LATE PAYMENT CHARGES: A Late Payment Charge at the rate of 1 1/2% per month or fraction <u>LATE PAYMENT CHARGES:</u> A Late Payment Charge at the rate of 1725 per month of raction thereof, which is an annual percentage rate of 1836, will be added to any balance remaining unpaid after February 28, 2021. Late Payment Charges will continue to be assessed monthly on any continuing balance (excluding accumulated Late Payment Charges) remaining unpaid. Late Payment Charges <u>will not be</u> assessed during the March – May 2021 period if a member has qualified for the Late Payment Charge Grace Period (see below).

#### EARLY PAYMENT DISCOUNT PROGRAMS

1. CABIN OWNERS: DISCOUNT OF \$25.00 IF \$1,310.00 IS PAID BY OCTOBER 31, 2020 Members owning homes are entitled to one Early Payment Discount of \$25.00 on each of the

assessed 2020 Cabin Dues under the following conditions: All outstanding dues, assessments and late payment charges must have been <u>received</u> by the Club by October 31, 2020; <u>and</u>

- Payment of \$1,310,00 for each cabin owned, and payment of \$821,00 for each lot owned
- (if any), is <u>received</u> by the Club by October 31, 2020. (Example: Cabin Dues of \$1,295.00 <u>plus</u> Dam Assessment of \$40.00 <u>less</u> \$25.00 Discount = \$1,310.00). 2. LOT OWNERS: DISCOUNT OF \$15.00 IF \$821.00 IS PAID BY OCTOBER 31, 2020
- Members owning lots are entitled to one Early Payment Discount of \$15.00 on each of the assessed 2021 Lot Dues under the following conditions: All outstanding dues, assessments and late payment charges must have been received by
- the Club by October 31, 2020; and Payment of \$821.00 for **each lot** owned is <u>received</u> by the Club by October 31, 2020. (Example: Lot Dues of \$796.00 <u>plus</u> Dam Assessment of \$40.00 <u>less</u> \$15.00 Discount = \$821.00).

Payment coupons are provided to each cabin owner. The suggested payment is \$150.00 monthly, though members may pay any amount at any time. There is no requirement that members follow the suggested payment program.

#### LATE PAYMENT CHARGE GRACE PERIOD -- CABIN OWNERS

The Club suggests that members use the \$150.00 monthly coupons for the five months ending February 2021. If on February 28, 2021, the Member has paid at least \$750.00 (\$150.00 - five payments or any other arrangement) for each cabin (home) owned, <u>has paid all lot dues and all the same and all the s</u> payments or any other alrangement for each caum frome. Orman the part of the club, the Membe has earned a LATE PAYMENT CHARGE GRACE PERIOD on their balance for three months ending May, 2021, Note that you can qualify for the LATE PAYMENT CHARGE GRACE PERIOD by paying

- all Lot Dues and Dam Assessments on the lots and for each home owned making:

  the suggested five monthly payments of \$150.00 using the coupons;

  one payment of \$750.00 for each cabin owned not later than February 28, 2021; any combination of payments totaling \$750.00 for each cabin owned by February 28, 2021.

Members should continue making (but are not required to do so) the \$150.00 payments for March and April. Following this schedule, the eighth (and last) payment, due not later than May 31, 2021, will be \$285.00 representing the balance of the 2021 cabin dues and dam assessment. ALL AMOUNTS DUE THE CLUB MUST BE PAID BY MAY 31, 2021. Increasing your monthly payment above the suggested \$150.00 will reduce your final payment in May.

Members failing to qualify for the LATE PAYMENT GRACE PERIOD will have their balance (excluding accumulated Late Payment Charges) subject to Late Payment Charges after February 28, 2021 when the 2021 Dues and Dam Assessment(s) are due.

#### SENIOR CITIZEN AND PERMANENTLY DISABLED DISCOUNT PROGRAMS discount may be taken. Members must meet all of the following requirements:

- One of the owners must be over 65 years of age or permanently disabled as determine the Social Security Administration. If applying for the Senior Citizen Discount for the first time, proof of age is required.
- All Club dues and assessments for each of the five years immediately preceding the year of application must have been paid in full by September 30 in the years in which the sam
- Not more than one home is owned, whether in Highland Lakes or elsewhere.
- The total annual income from all sources of all owners and members of the family residing in the same residence in Highland Lakes, or in the case of a lot owner the total annual income from all sources of all owners and members of the family residing in the residential address on file with the Club, including Social Security benefits, must not exceed \$28,399 if single or \$34,817 if married. Income levels are identical to eligibility under New Jersey? Pharmaceutical Assistance to the Aged and Disabled Program (PAAD). Income levels will be adjusted automatically based on the 2021 levels established by the State of New Jersey late in 2020.
- PROOFS REQUIRED: A copy of the New Jersey PAAD card must be filed with the Club. For those without a PAAD card, a copy of the Federal Income Tax Return or other verifications with supporting documentation for calendar year 2020 or 2019 must be submitted for review. For either discount, the Club specifically reserves the right to request such additional proofs as may be necessary in order to determine eligibility. All copies of income verification information, etc. will be returned - no copies will be kept at the Club Office.

After the signed application for the Senior Citizen or Permanently Disabled Discount has been filed and approved by the Club, Cabin Owners may deduct \$677.50 from the 2021 Cabin Dues for the approved Discount, and Lot Owners may deduct \$406.00 from the 2021 Lot Dues for the approved Discount.

Note: Applications must be submitted each year for the discount. If you received a discount last year, an application will be mailed to you in January 2021, which should be returned not later than February 28, 2021. <u>Applications for the discount will not be accepted after May 31, 2021.</u> If any part of the 2021 Dues and Assessments are unpaid on July 31, 2021, the 2021 Senior Citizen or Permanently Disabled Discount will be <u>FORFEITED</u>.

**GOODWILL FUND:** Financial assistance with the payment of the 2021 Dues and Assessments is available to those members who have experienced a catastrophic event and who are unable to pay their current year dues and assessments. Examples of a catastruphilic event include, but a not limited to, personal events such as: the death of a member or a member's spouse; a life pay their current year dues and assessments. Examples of a catastrophic event include, but are not immed to, personal events such as: the death of a member of a member's spouse; a lift threatening filmess, serious accident or injury, or a criminal activity against a member (assa theft) which has seriously impaired the financial stability of the household. Applications for assistance must be received by July 31, 2021. Voluntary contributions to the Fund are always

INITIATION FEE: \$2,000.00 - When persons take title to property in Highland Lakes for the first time, even when they join in the ownership of property with someone who currently owns property in Highland Lakes, they become a new owner and are required to pay the initiation Fee. The Initiation Fee is due on or before the first day of the first month following acquisition of title. Members who sell their only property in Highland Lakes, and purchase another within one calendar year, are exempt from the assessment of the Initiation Fee. Please always check with the Club Office when purchasing property or considering changes in your recorded Deed

BUYER'S PROPERTY TRANSFER FEE: \$150.00 - Applies to all transfers of property between Members. The Buyer's Property Transfer Fee is due on or before the first day of the first month following acquisition of title.

RETURNED CHECK CHARGES: \$40.00 - Members will be assessed a \$40.00 charge for any check returned to the Club as not satisfied by the bank upon which it is drawn. Additionally, an assessment of \$5.00 per day will be made, beginning on the day the returned check was received by the Club from the bank, for each day Membership Materials (badges, and permits) are not returned to the Club Office after the Membership Materials were delivered.

STATUS REPORTS: \$50.00 - Reports on the status of outstanding dues and assessments, required for all real estate sales, ownership changes, and mortgage refinances/modifications are available for a fee of \$50.00 and should be requested seven days in advance of the closing. There is no charge for reports issued directly to members for mortgage refinances and modifications.

ACCOUNT MAINTENANCE FEE: \$250.00 – Assessed when a member's account is referred to the Club's attorneys for the purposes of collection, foreclosure, and/or bankruptcy.

BADGES: Owners who have paid the dues and assessments in full will receive badges for each er (limit of two badges for corporations, partnerships, associations, etc. – "Entities"), The following is applicable to Owners other than Entities:

Owners may obtain, at no additional cost, Family Badges for each family member who resides with them in Highland Lakes. For seasonal residents, this includes Family Badges for those who reside in Highland Lakes for at least thirty days.

For an Owner's non-resident parents, children and grandchildren, Family Facilities Badges are available for \$10.00 each. Family Activities Badges, for \$50.00 each, are available for those avanaure for \$10,000 each. Family Activities badges, for \$5,000 each, are available for fhose persons permitting participation in the Club's Rostered Activities. Badges that are lost are replaceable as follows: Owner, Family or Family Facilities Badge: \$10.00; Family Activities Badge

Membership Permits for your boat, car, and dock are available from the Club Office at no additional charge.

#### GUEST BADGES and BEACH GUEST PASSES: \$1.00 PER DAY

Available for purchase by Members in Good Standing upon presentation of the 2021 Membership Card or a 2021 Owner's Badge. Complimentary Guest Parking Permits w available with the purchase of Guest Badges. Subject to limitations as established by the Voting

In response to the COVID-19 pandemic, the Voting Board adopted the following policy changes which are expected, with modification, to continue in calendar year 2021. Please consult the Club's website - www.hlcc.org - for updates.

- for guests at beaches, a Beach Guest Pass is available during the beach season
- 2. for other guests (parks, fishing, courts, etc.) a Guest Badge is available but is not valid for

- 1. guest badges are valid at all Club facilities except beaches and the swim lanes.
  2. a member may purchase not more than twenty Guest Badges per day for use at Club facilities (parks, courts, fishing, Clubhouse) except beaches upon presentation of the membership card or owner's badge, and identification.
- advance purchases of Guest Badges are authorized, provided that the purchase date is four days (including the purchase date) or less from the requested date. All purchases are final, not exchangeable and not refundable.

#### BEACH GUEST PASSES (Valid during the beach season)

- members may purchase under their membership number not more than two Beach Guest Passes daily for one designated beach upon presentation of the membership card or owner's badge, and personal identification. No guest parking passes for beaches will be issued.
- 2. Beach Guest Passes are available for purchase on the day ONLY advance purchases are not
- 3. the following Beach Guest Passes are available each day: Beach 1 15; Beach 2 10; Beach 3 7: Beach 4 – 2: Beach 5 – 2: Beach 6 – 2: Beach 7 – 2.
- ach Guest Passes are valid ONLY for the purchased beach and not valid at other beaches or

Members who rent their premises at any time, regardless of the length of the term of the rental, are required to register their property as a rental with the Club office. Registration of th property must be done by its owner(s) no later than the first day of the first occupancy by tenant(s). A copy of the Application may be obtained by contacting the Club Office

Members who rent their premises are also required to register all tenants with the Club office upon each change of occupancy, and must establish the tenants as Associate Members prior to each tenancy. For each tenancy, For each tenancy, I members must pay the corresponding Associate Member dues as established in the Dues and Assessments schedules.

Associate Member dues established in this Dues and Assessments Schedule are:

- 1. Year-round basis (no badges included) \$300.00 Badges: \$10.00 each (household members
- 2. Monthly basis (no badges included) \$100.00 Badges: \$ 1.00 each per day
- 3. Weekly basis (no badges included) \$ 50.00 Badges: \$ 1.00 each per day

#### Associate Memberships expire on December 31, 2021

Compliance by members with the Club's By-Laws is not optional. Failure to register properties and tenants in accordance with Club policy, or misrepresentation of the amount of rentals or rental durations, will subject the Members to a penalty assessment in an amount equal to the then current annual cabin dues for each violation, together with late payment charges if the penalty assessment is unpaid on the first day of the second month following the assessment of

Associate membership badges to be used by tenants of members in good standing may be purchased by registered tenants at the Club office or Activities Center only. Tenants who rent annually or monthly may purchase activities badges for household members only, for \$10.00 per badge. Tenants who rent weekly may purchase daily badges for \$1.00 per badge. Charges for badges in subsequent years are established by the Voting Board in its annual adoption of the Dues and Assessments Schedule.

Associate Members renting/leasing properties owned by members in good standing are eligible for garbage service, parking permits and boat permits, in accordance with Club policy. Associate members' children with activities badges are eligible to participate in "rostered" activities, such as Swim Team, softball, tennis, basketball, sailing, etc.

Members who rent their premises are required to notify their tenants that the tenants are subject to the By-Laws, Rules and Regulations, and all policies of the Club. In the event the tenants fail to comply with the By-Laws, Rules and Regulations, and all policies of the Club, in addition to any action the Club may have against the tenants, the Member shall be responsible. for the violation of the tenants, including the imposition of fines and assessments by the Club.

To date I must say that I am pleased with the community response to the initiation of the carry-in/carry-out program. I always pack a trash bag in my backpack I take to the beach and my pickleball bag, and have only had to put them to use once all summer. Thanks to all of you for your diligence and community spirit.

However, when it comes to trash along our roadways, that is a different story. The Ecology Committee asks that all residents take part in a day to day clean-up of our properties and roadways. Take the time to patrol a section of your neighborhood, carry a trash bag and pick up any trash that might have escaped from a neighbor's trash can on pick-up days or, sadly something carelessly tossed out of a car window. It does not take much time, and during this pandemic we all have disposable gloves to use for such a

Speak to your neighbors. Get the children involved. If any of you are interested in "adopting" a section of road please give me a call. It would be your responsibility to keep it free of trash and I'd give credit in subsequent editions of the Newsette. Next spring we will have the annual roadside clean-up once again.

# **Ecology Corner**

#### **Emerald Ash Borer...More**

Due to the invasion of the Emerald Ash Borer and necessary removal due to construction, septic replacement, etc. we have lost and will be losing many of our old trees here in Highland Lakes. The native ash accounts for one third of all of the trees in our community. This is a good time to look into planting a tree native to our part of the country.

Consider planting a red maple (Acer rubrum), a medium-sized tree from 40 to 60 feet high at maturity with a rounded or irregular crown spreading to 40 feet. Young bark is smooth and gray, turning rough and darker with age. Red maple transplants easily and grows very fast in moist soils, but it can also do well on dry sites. (Fall color is shown below.)

Red maple is one of the best named of all trees. There is something red in all seasons - buds in winter, flowers in spring, leafstalks in summer, and brilliant foliage in autumn. This pageant of color, along with red maple's relatively fast growth and tolerance to a wide range of soils makes it a widely planted favorite.


