# Governance in Highland Lakes - Part 2

#### Committees and Volunteer Involvement

"The Club's manager is responsible for implementing all of the initiatives and special projects that are authorized by the board... this means the manager works closely with various committee chairs depending upon the project at hand".

Wow! What a mouthful! As a life-long Highland Laker, I never gave much thought to how our community is run. In decades of living here, I've often had passing thoughts like "Why did we do this?" or "Can't we do that? It seems so easy..." but never spent much time thinking about the details. This article is part two of a series intended to explain how our community is governed, and I would like to express my gratitude to 1st VP Sue Ross for spearheading this idea and writing the wonderful article articulating the relationship between members, Club management, and the volunteers that comprise various committees as well as the Board of Trustees.

As you drive through HL, check the website for info, attend activities and see infrastructure improvements, please take a moment to ponder how those things came to be. It reminds one of the smart phone commercial - "there's an app for that!" As you look around your community, note that every aspect has involved at least one committee - "there's a committee for that!"

Committees are groups of invested members committed to sharing their knowledge and experience to improve our community. Committees are so integral to this community that they are mentioned 23 times in HLCC By-Laws. In a political structure, the committee chairs could be equated to the President's Cabinet; these are trusted advisors that have agreed to spearhead research, advise and implement any activity tasked by the board of trustees or Club manager. The only official requirement for joining a committee is HLCC membership, and willingness to be involved.

Unofficially, common sense prevails and any personal interests you have can be dovetailed with the appropriate committee. Artists work with the Communications Committee to create logos and those awesome e-blasts sent weekly. Professional writers and marketers help create the Newsette and maintain the website. Builders, electricians and engineers work with Road, Buildings & Grounds and Dam Rehabilitation Committees. Those active in social/volunteer work and fundraising join the Goodwill Fundraising Committee. Water and nature lovers are involved with Ecology and Fishing. Those interested in making sure that only members use our facilities donate their time Badge Checking. Rules & Bylaws and the Elections Committee members assist with governance issues. Planning Committee members would naturally attract visionaries, community planners, architects, etc.

Committees exist for very specific purposes (outlined in detail on HLCC.org) and work with the Board and Club manager, often doing research and spending countless hours to develop the information necessary to fulfill the needs of day-to-day operations and special projects. Members and trustees often suggest ideas then wonder, "what ever happened with that?" Those that attend board meetings on a regular basis know that all suggestions get discussed. Even seemingly insignificant issues must be looked at in depth, and committees are tasked to do that research. Committees advise the manager and Board on research they have completed and offer insights as to how projects may be accomplished while keeping in sight the needs and wants of our community. Committees also monitor the community and come to the Board or Club manager with ideas and suggestions. At least one Board Trustee is assigned as liaison between the Board and each committee.

Generally speaking, there are two types of committees. One type focuses on activities and communication, the other on infrastructure and long-term goals (some committees do both.) One look at the community calendar will see activities almost daily, with at least 1 - 2 committees being involved in each. Events like the Fishing Derby, Winter Carnival, Family Day, New Year's Eve Party and more, would not exist without active committee membership and

willingness of multiple committees to work together. We would not have a new roof, parking lot, rain garden, Beach 1 upgrade, or Beach Hut - among other things - without the hundreds of man hours donated by Buildings and Grounds.

As you look around Highland Lakes, please take a moment to look deeper. From the lighting to the mulch in the playground, a committee has been involved. When you look at that new dock, know that similar unpaid man-hours went into the planning and research. Safety, liability, cost, maintenance, warrantees, usefulness and member enjoyment are ALL taken into consideration first by the applicable committee, then by the Board. Think of the biggest party you've ever thrown - has it topped 200 guests? Even in the "slower" winter months there may be three large events at the clubhouse each month, each topping 150 guests.

In preparing for this article, my mind kept drifting to an old TV show, School House Rock, and the episode on How a Bill Becomes a Law. I kept thinking of how that show simplified a huge concept that many adults don't understand into a kid-friendly format by following one bill through the whole process. With that in mind, I present my own HLCC version:

How an Idea Becomes Reality; the Story of the Community Map. A few members realized that there was no official map of Highland Lakes that included freeways, beaches, boat launches and recreation areas. The idea was discussed unofficially, then proposed to the Club manager, who agreed that map would be helpful to the community at large as well as new or prospective members. The idea was then raised at a board workshop and met with widespread approval, then redirected to a committee for further investigation and implementation. Seems simple? Not really. Before the drawing process began, Board discussions were had as to how to publish the map. Consideration was given to the issue of how to ensure accuracy, while also ensuring that our community remains private. Eventually at least three committees, along with the Club manager, office staff, and local authorities were all involved to ensure that details were accurately drawn. Zoning, property lines and deeds were reviewed. After a mountain of work, a basic outline was developed. Maps require precision and artistry, so the Communications Committee was asked to help with drawing, coloring, and detail work. In short, that lovely map that is now available to all members took over a year to develop properly, with over a dozen people and three different committees being involved.

The Board of Trustees and Executive Board are volunteers and community members, just like you, who have a sworn duty to ensure that all Club decisions are made with careful consideration, due diligence, and the benefit of ALL members in mind. Every dues-paying member has a right to attend board or committee meetings. All we ask is that you show up and be involved. Stay for the duration of a meeting, not just the part that interests you. Learn how the Board works, and how our committees can use your involvement. To quote the timeless wisdom of Dr. Seuss..." UNLESS someone like you cares a whole awful lot, nothing is going to get better. It's not."

## **2016 Badges and Permits**

#### **Available for Pickup April 18**

Starting April 18, 2016, members who have paid their dues and assessments in full may pick up their 2016 membership badges and permits at the Club Office. Office hours are Monday through Friday, 9 am to 4 pm, and on Saturday, from 10 am to 1 pm.

Please pay particular attention to the emergency information section on your badge pick-up form. Having emergency contacts and telephone numbers on file at the Club Office makes it much easier to contact you in an emergency.

Parking permits are valid only for those vehicles listed in the records at the Club Office. If you have replaced any vehicles, please bring copies of the appropriate vehicle registrations.

A complimentary Community Map of Highland Lakes, prepared by the Communications Committee, showing the twelve geographic sections of Highland Lakes and the locations of Club facilities, will be offered when you pick up your badges.



## **Rules for Boat Storage on Club Docks and Racks**

With the boating season rapidly approaching and new docks on order at ten locations including Indian Lake (East Highland Lake), Lake 1 (Upper Highland Lake), Lake 5 (Upper West Highland Lake), Comet Row and freeways on the Main Lake (Highland Lake), it is again time for members to review the Club's boat storage rules before placing their boats on Club property.

Extensive changes were adopted by the Voting Board in May 2014 that addressed the storage and use of Club lands, boat racks and docks for boat storage. These changes were necessitated by the use of boating facilities by members not in good standing, members who fail to remove their boats from docks and boat racks in the fall, members who leave boats tied up to trees, etc., and those who disregard the boat lottery system for assigned space.

With an investment of more than \$500,000 in new docks over the past three years, these rules also prohibit any modification, drilling, etc. and establish requirements for how boats are to be moored to the new docks.

These Rules, in six parts, constitute the Club's Rules pertaining to the storage of boats, kayaks, windsurfers, etc. on Club lands, boat racks and docks.

A. HOLD HARMLESS: The member agrees to indemnify and hold the Club harmless from any injury, damage or loss resulting from the use and storage of the member's boat anywhere on Club property, including but not limited to lands, docks and boat racks. The member, by keeping their boat on Club lands, docks or boat racks, acknowledges that the Club shall not be responsible for any injury, damage or loss whatsoever resulting from the removal, transport and storage of the boat, and use of the Club's lands, docks and boat racks.

B. IMPROPER STORAGE: Improper storage is defined as storage on lands owned by the Club other than on docks and boat racks, storage anywhere on Club properties without a current membership permit, and storage in violation of Rule 24 (C.), (D.) and/or (E.) below. Boats improperly stored will be removed to storage immediately.

C. STORAGE ON DOCKS and RACKS AFTER OCTOBER 15: All boats must be removed from Club docks not later than October 15 of each year. In alternating years,

# Message to all Returning Lifeguards

Lifeguard data forms were recently mailed out. If for some reason you did not get your mailing or were recently certified and wish to apply for the 2016 season, you can request an application by calling the Highland Lakes Club Office - 973-764-4366 or by email to hlcc@2warwick.net.

Preseason schedules will start the week of June 20. Preseason work will be distributed evenly to those who are interested beginning with senior guards getting first choice. This does not mean that only senior guards will work preseason.

If you should have any questions or concerns, please leave your name and phone number with the Club office and I will return your call. Thank you. all boats must be removed from boat racks by October 15, as determined by the Boat and Dock Committee and as published in the Newsette. Boats stored after October 15 in violation of this Rule will be removed to storage immediately.

D. UNAUTHORIZED USE OF SPACE ON ASSIGNED DOCKS: Space on certain Club docks is restricted to assigned use only. These docks are located at Club Park, Comet Row, Eckhart Sailing Center, Beach 3, Beach 4, and such other, future locations as may be authorized by the Voting Board. Docks subject to this assigned space requirement are marked with appropriate signs. Dock space assignments are managed by the Boat and Dock Committee upon receipt of applications from members in good standing and are assigned by the committee through the use of a lottery system and other methods. Boats not authorized by the committee on these docks will be removed to storage immediately.

E. DOCK MODIFICATIONS AND UNCOATED WIRE PROHIBITED: Members may not drill holes in any dock or fasten any device without the authorization of the Boat and Dock Committee. Only ropes, chain and plastic coated wire are authorized to attach a boat to a dock. Uncoated wire is specifically prohibited. Members are responsible for all damages caused by unauthorized drilling or fastening to the dock or excessive wear or chafing caused by the use of unauthorized attachment methods. Boats stored on docks in violation of this Rule will be removed to storage immediately.

REMOVAL TO STORAGE, PENALTIES FOR F. VIOLATIONS: Boats, kayaks, windsurfers, etc. of members stored in violation of these Rules shall be removed to storage, and will be subject to a special assessment of \$100.00, and a daily storage charge of \$5.00, calculated from the date the boat was removed to storage up to November 15, when a special winter storage fee of \$250.00 will be imposed. After June 15, a disposal fee of \$250.00 will be imposed. Boats may not be retrieved between November 15 and April 15. Members whose boats are identifiable through the boating permit shall be provided notice by regular and certified mail that the boat has been removed to storage. The Club may, in its sole discretion, elect to acquire title to any boat that has been determined to be abandoned, in compliance with the "Abandoned Vessels Disposition Law," N.J.S.A. 12:7C-7 et seq. (Amended September 23, 2009).



# Birding at the Lake

It is with great pleasure that I share my love of birding with the community. We are fortunate to live in a watercentered environment that attracts both common birds and accidentally migratory birds. The spring abounds with species of birds and is a great time to bird watch. It is also a time when birds can move out of their natural habitats. Everyone can recognize a woodpecker when they are pecking on the bark of a tree, or on the side of a roof or house. There are five woodpeckers that are commonly found around the lake: the Downy Woodpecker, the Hairy Woodpecker, the Red-bellied woodpecker, Northern Flickers and the Pileated Woodpecker.

In the spring woodpeckers can be both beautiful to look at and pests that hammer away loudly on our houses. Woodpeckers hammer to attract mates, defend their territory, excavate nesting or roosting sites, and to search for insects to eat. Wooden shingles, cedar or redwood siding, plastic or metal gutters, chimney caps and light posts are selected drumming sites because they produce loud sounds. Drumming is most common during mating season in the spring and usually ends by July 1. Once a woodpecker stakes out its territory it is difficult to drive them away, so prevention is the best way to avoid the noise and damage to your home. There are simple methods to repel woodpeckers that do not harm them in any way. These techniques include visual repellents, loud noises, or providing nesting boxes.

First make sure insects are not dwelling in your wood siding, as this will attract woodpeckers. Once this has been established, the use of visual deterrents is inexpensive and effective. Cutting long rectangular strips of black plastic and hanging them from the gutters or siding will scare away the woodpeckers. Decorative pinwheels with reflective vanes, or aluminum pie tins hung from fishing line and placed near a previously woodpecker damaged area or potential hammering sites will also frighten away woodpeckers. Allow the wind to blow the strips, pinwheels, and pie tins freely. Owl effigies are more expensive and generally are unsuccessful for frightening away woodpeckers. Where woodpeckers are persistent, use two or more of the above frightening devices simultaneously. Loud noises will also deter woodpeckers.

If a woodpecker has made holes in your siding fill them as quickly as possible with spray foam so there will be no noise produced upon the woodpeckers return to excavate the hole. Providing nesting boxes also may reduce the

Thanks! chance of hammering on your house. Once you have scared the woodpeckers back into their natural habitat now you can enjoy them!

You don't need binoculars to see this woodpecker. The Northern Flicker is easy to spot hopping around in your garden, under trees. The Northern Flickers is a large (11 to 14 inches), brown woodpecker that is speckled with blackscalloped plumage. Unlike most woodpeckers that you see eating insects from the bark of trees, the Northern Flicker can be found foraging on the ground. Hopping back and forth, it uses its bill to move leaves and find ants and beetles. Once it finds these insects it can be seen digging for them with its unusual, slightly curved bill. In flight it puts on a show with a flash of yellow color on the wings and a bright white flash on the rump.

Vernon Township advises that aerial spraying for gypsy moths is scheduled to take place on or after May 16, 2016. This year's recently introduced township budget includes \$124,600 for the aerial spraying program. The township will mail notifications to all affected residents at least ten days in advance of the proposed date of treatment, publish notices in local newspapers, and coordinate the spraying with the local school district. Please note that the spraying timetable in the northern part of New Jersey is contingent on weather and wind, so adjustments may be necessary.

# News from the Boat Dock Committee

#### **Additional Docks approved for the 2016 Season**

The Voting Board has approved additional funds for the purchase of new docks at the following locations: Canistear Road boat launch, Beach 4, Shadow Path, North Cove Path, White Tail Trail, Roaring Brook Path, Sunrise Path, Comet Row, Beach 7, Pocasset Road and Beach 1. The old docks will be replaced with the new style plastic docks which should provide additional stability, reduce maintenance costs, while also eliminating exposed foam flotation breaking free and floating in the lakes.

While our boaters should enjoy the benefits of these new docks for many years to come, we would like to ensure they are used properly. The following rules should be reviewed by all members prior to use of these docks:

DOCK MODIFICATIONS AND UNCOATED WIRE PROHIBITED: Members may not drill holes in any dock or fasten any device without the authorization of the Boat Dock Committee. Only ropes, chain and plastic coated wire are authorized to attach a boat to a dock. Uncoated wire is specifically prohibited. Members are responsible for all damages caused by unauthorized drilling or fastening to the dock or excessive wear or chafing caused by the use of unauthorized attachment methods. Boats stored on docks in violation of this Rule will be removed to storage immediately.

As noted in the last Newsette, applications will be required for the new pontoon boat dock at Comet Row. These applications are available at the Club website (www. hlcc.org), at the Club office, or a call to the office to request a mailing or email of the application. Please include all information requested.

# About Changes in Your Recorded Deed

In planning changes to your ownership of property that would be reflected in the recorded Deed, contacting the Club Office before you do so for guidance is advisable and will eliminate any misunderstandings.

The Club's By-Laws, in part, define Active Members as those who own property in Highland Lakes. When persons take title to property in Highland Lakes when they do not own other Highland Lakes property at that time, even when they join in the ownership of property with someone who currently owns property in Highland Lakes, they automatically become an active member and are required to pay the Initiation Fee. If you are considering adding anyone to your Deed, a wife, parent, child, friend, etc., please be aware of these By-Law requirements.

Sometimes members form a living or family trust as part of their estate planning. However, even this type of trust is a different, and therefore new, owner of property, and the payment of the Initiation Fee is required.

# Sailing Tube Storage

Ahoy sailors! It's time again to think sailing and tube storage. This year we have expanded the number of tubes at Eckhart Sailing Center from 15 to 22 in total. We will also be adding 5 new tubes at Comet Row. As always, Junior fleet racing sailors have the first right of refusal for the tube storage system at the Eckhart Sailing Center. Junior sailors and/or their parents need to email to request a tube no later than July 1, 2016, or call to reserve a tube for this sailing season. Please mark emails: Sailing Tube Request in subject line to HLCCSailing@gmail.com with name of sailor, parent name if junior and fleet sailing.

We will confirm active junior sailors with the Junior Fleet Captain, email you the release form to sign/return and assign your tube number. Additionally, any remaining tubes not assigned to juniors will be available to the other racers in fleets docked at Eckhart Sailing Center and Comet Row via email request. First come, first served.

Here are the basic rules for review to use the tubes:

1. Do not put wet sails in the tubes. Dry sails only.

2. Junior sailors have first right of refusal due to parent transportation considerations.

3. Lock and combination information must be provided on the form.

4. No wet items of any kind shall be placed in tube.

5. Only HL racing fleet sailors can utilize tubes.

6. Only non-lakefront members can use this option.

7. Only one set of sails with spars per tube.

8. Storage is only during the sail racing season. No year-round storage.

9. When Club docks go in water and are taken out, so must your sails!

10. Any abuse of the tubes forfeits your rights to use them.
